

# Annual Report 2022 – 2023

#### Tēnā koutou members

On behalf of the Trust Democracy Committee, I am pleased to present our 2022 – 2023 Annual Report.

For a small society that is only 3 years old, Trust Democracy (TD) supported an impressive amount of activity across a broad scope during 2022-23. This was enabled by understanding 'democracy' and 'democratic' as not just electoral representative democracy but as a political system that empowers inclusion, forms collective agendas and wills, and has capacities to make collective decisions. This broader understanding of democracy is what distinguished Trust Democracy from most commentaries about NZ's democracy.

#### Focus for 2023-24

Inter-related priorities for 2023-24 will include:

- To develop a strategic plan to help focus our efforts for impact and develop the organisation to support this.
- To increase the number and diversity of our members
- To continue to support the Porirua Talanoa-Wānanga deliberative experiment in Te Tiritiand community-led governance
- TD will continue to encourage and support local authorities to develop more deliberative and participatory forms of governance through, for example, joint educational webinars with Local Government New Zealand
- To raise awareness amongst journalists and commentators about new forms of democratic engagement that will be needed to address the complex issues we face.
- Maintain the relationship with the Kettering Foundation, USA, and help organise a New Zealand based deliberative democracy event in Auckland during October 2023.

#### **Publications**

Over the course of 2022-23, Trust Democracy submitted 5 submissions, sent emails to all local body representatives about deliberative public engagement, wrote letters expressing our concern about the proposed Charities Act reforms to the responsible Minister and then to all MPs, and was a signatory to 3 letters to the Minister for the Public Service regarding the Open Government Partnership along with other civil society organisations. Two of the submissions were prepared in collaboration with Trust Democracy members who accepted invitations to help. Trust Democracy took part in a collaborative process to help prepare a submission on the Aotearoa New Zealand Public Media Bill submission after receiving an invitation from the organisers, Koi Tū: The Centre for Informed Futures at the University of Auckland.
